








Stages of Pandemic Reaction

Overarching Legal Principles in USA

- Federal jurisdiction with respect to safety of air travel is exclusive and preempts state and local decisions. *Air Transport Ass'n of America, Inc. v. Cuomo, 520 F.3d 218, 224–25 (2d Cir. 2008).*
- Closure of airports for public health concerns would violate obligation to keep airport open and available for the public. Grant Assurance 19, 49 USC 47107(a)(8)
- Legal restrictions generally not suspended during pandemic
 - Revenue use
 - Privacy
- Broader legal authority to close non-aeronautical activities
- Airline Deregulation Act, 49 USC 41713
 - Airports cannot regulate airlines
 - Airports cannot take action that would regulate passengers
- Airports are not public health agencies and are limited in use of funds for the operating cost of the airport. 49 USC 40116





Spring 2020 Airline Traffic








Early Pandemic Questions - March-April 2020

- Can we close parts of the terminal or airport?
 - Federal grant obligations
 - 49 USC 47107(a)(8)
- Can we limit access to the airport terminal to prevent transmission of virus?
- Where and how can we park unused aircraft?
- How do we treat our own employees when most workers are staying home?
- Who do we talk to and coordinate with?

Concession Relief >>>

Official Legal Direction / Guidance

- Fast moving
- Not always consistent
- Often lacked practical application
- Rarely coordinated among agencies
- Need to return to fundamental legal principles

Extrinsic Financial Considerations

- Bond covenants
- Contractual commitments (parity, mostfavored-nation)
- Prohibitions on 'gifts of public funds'



Regulatory Relief

- Regulatory discretion
 - Use of airport space and revenue for pandemic-related purposes
 - Direct payments for pandemic relief to air carriers and others
 - Use of airport movement areas for parking
 - Partial closure
 - Distinctions among concessionaires
- Direct relief
 - Deadline waivers
 - Revenue flexibility (aeronautical vs non-aeronautical use)
- No relief
 - Passenger health regulation
 - Interference with airline-passenger relationship






Domestic Recovery

2019 Actual = 100




Delta Airport Consultants "Landed in a pandemic departing in a recession" 8/2020

Scenarios for Traffic Recovery at a Generic Airport








Reopening Challenges

- Pandemic surges not linear recovery
- Politics overlay everything (!!)
 - Mask mandates
 - Vaccine mandates
- Deciding which reopens first passengers or businesses







Considerable literature on pandemic lessons.... but little legal guidance






What did we do right? Wrong?





Lessons - Need Better Advance Planning

- Necessarily unpredictable
- Early assessment and repeated reevaluation of risk
- Standard Operating Procedures for next public health crisis
- Special internal coordinating team
 - Operations
 - Concessions/Tenants
 - Airlines
 - Legal counsel
 - Regulators
- Point of contact for other agencies
 - Public health
 - Airport and airline regulators
 - Security agencies





Lessons - Understand Regulatory Conflicts

- Understand scope of legal and contractual authority
 - Airport proprietor
 - Airlines and other service providers
 - Businesses at airport
 - Public health agencies
 - Federal government agencies
- Understand statutory mission of government actors
- Reconciling conflicts in statutory missions
- Identify and anticipate need for regulatory relief



Lessons - Address Other Legal Issues

- Personnel, union and employment matters
 - Layoffs / furloughs
 - Work from home
- Airport proprietor contractual obligations
- Short term non-financial contractual relief
- Need for emergency procurement protocols
- Need for liability assessment
 - Virus transmission
 - Contractual violations
 - Premises liability



Lessons - Legal Policy Issues

- USA: protocol or policies for protection of personal liberties
- Understand public health powers (quarantine, removal, etc.)
- Data protection and privacy
- Restoring public confidence in safety, cleanliness of facilities



Lessons - Operations and Facility Challenges

- Point of contact and decision maker on landside operations
- Decision tree for restrictions on landside operations
- Different closure, mothballing, reopening accommodation for different users
- Operational protocols to ensure fair treatment
- Anticipate and plan for public confusion and opposition
 - Personal liberties
 - USA: freedom of speech, assembly, religion, search-andseizure
- Plan for use of different airport facilities
 - Airfield
 - Terminal
 - Ancillary facilities



Lessons - Financial and Tenant Relief Needs

- Avoiding playing favorites among stakeholders
- Understand (revise?) terms and conditions of tenant contracts
 - Most favored nation clauses
 - Force majeure
 - Subordination to regulatory mandates
- Equitable treatment and avoiding unjust discrimination
- Protect airport proprietor long-term financial viability in the face of demands from stakeholders
- Distinguish relief to aeronautical and non-aeronautical stakeholders
